### **URGENT ADVICE VICTORIA COVID-19 STAGE 4 RESTRICTIONS - Victorian Petrol Stations can remain open after curfew**

Dear UCB Member,

Today, 2<sup>nd</sup> August 2020, The Premier of Victoria, The Hon Daniel Andrews announced that Victoria from 6.00pm this evening will enter a State of Disaster, this action was also taken last summer in relation to the Bushfire emergency.

From 6pm tonight, Metropolitan Melbourne will also move to Stage 4 restrictions with stronger rules to limit the movement of people – and limit the spread of this virus. The key feature of Stage 4 is the inclusion of a curfew – from 8pm to 5am. The only reasons to leave home during these hours will be work, medical care and caregiving.

*UCB are in receipt of written communication from Lill Healy, Deputy Secretary, Border Relations, Supply Chain and Logistics, Victorian Department of Job, Precincts and Regions. Lill's correspondence indicates clearly "that given petrol stations provide fuel which is an essential service they are not subject to the 8pm curfew". (For clarity, Lill Healy's email correspondence has been shared via Ben Foster (Victorian Premier's Office) and Mark McKenzie of ACAPMA).*

*Mark McKenzie (ACAPMA) has also confirmed to UCB that, "this will also mean that service station staff will be able to travel to work in the usual manner, but all service stations will be required to demonstrate COVID Safe operating practices at all times".*

ACAPMA are also still working with the Victorian Government, SA Government

and NSW Government on the cross border fuel transport issue.
