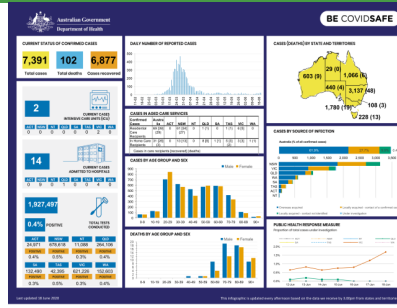
## **NATIONAL WAGE CASE DECISION 2020 AND ITS IMPLICATIONS.**



The Fair Work Commission (FWC) undertakes the National Wage Case each year to determine if, and to what level the minimum wage should be increased. Today the FWC handed down the decision that the minimum wage will be increased by from the first pay period on or after the 1st July 2020. This will have an impact on the base rate in all Modern Awards.
