## Cleaning to prevent the spread of COVID-19 "Cleaning and disinfecting are two different processes"

**Safe Work Australia** has released new guidance for cleaning and disinfecting surfaces - The Guidance emphasises the importance of cleaning (removing dirt) and disinfecting (removing viruses and unseen bacteria). It also provides some detail on the cleaning required for a retail space or workplace that has had a confirmed or suspected case of COVID-19 – including a two stage clean with 1000 parts per million Bleach Solution, employee PPE required and the option to continue trading while cleaning occurs.
